- Mr. Joye made a motion to reject the counteroffers made by Mr. Eby in response to the Board's proposed employment agreement amendment as approved on June 25, 2020 and to declare that there is no agreement on terms to extend Mr. Eby's Employment Agreement beyond June 30, 2020
- There was a second by Ms. Mortell and the motion carried
- A motion was made by Mr. Joye that due to Mr. Eby's actions of clearing out his office and returning his keys and property to the Authority on June 30, 2020 that the Board consider these actions as Mr. Eby's resignation and to accept Mr. Eby's resignation
- Mr. Kozlosky seconded the motion and the motion carried
- Mr. Coudriet announced that the Deputy Director will serve as interim and has the support of the Board
- Mr. Joye made a motion that in the event a court would not find that Mr. Eby resigned through
 the actions of clearing out his office and returning his keys to Authority properties and assets or
 that the expiration of his Employment Agreement did not terminate his employment that the
 Board terminate any at will employment relationship with Mr. Eby.
- Mr. Cheatham seconded the motion and the motion carried
