- Ms. Fox confirmed a roll vote was not required as all members were present in person

#### DISCUSSION ON DRAFT NETWORK DESIGN REPORT

- Mr. Coudriet recognized TransPro and thanked Mr. Browning and his team for joining the meeting
- He stated we as a Board need to begin to build consensus around a redesign of the system
- Mr. Coudriet stated he appreciates the work that TransPro has done
- He stated he is not speaking for the County, but his comments are in line with each of our County members; we like the work that has been completed to date and like the alternatives that have been presented
- Mr. Coudriet stated we are not looking for action to move this forward today
- He stated what we do need is to get a sense of where the Board is as a body, confirming what
  changes we like and those we would like to see amended or modified so we can bring the work
  of TransPro to a close and we begin to communicate back to the City Council and County
  Commission what the Board would like to endorse
- Mr. Coudriet added endorsements are needed to provide clear direction for the new transit director and the Board's successors
- He confirmed the Board is not asking TransPro to go through the presentation but spoke to a report issued to the Board by Mr. Browning prior to the special meeting
- Mr. Coudriet asked Mr. Browning to speak to any subtenant changes contained in the report, if not he requested to open the floor for discussion among Board members
