CALL TO ORDER

• In the absence of Chairman Coudriet, Vice Chairman Cheatham called the meeting to order at 12:35 pm

DISCUSSION AND ACTION ON UNCW CONTRACT

- Mr. Chatham recognized Ms. Matheny to introduce the addendum to the contract with UNCW for transportation services
- Ms. Matheny stated per the report introducing this item, the Authority worked in consultation with partners at UNCW to scale transportation services to meet a revised demand for FY21, the third and final year under the current agreement
- She confirmed revisions to UNCW operations implemented in response to the COVID-19 health crisis resulted in a need to scale transportation services to meet a revised demand
- The revised operational schedule and contract addendum reflects a 32% decrease in service levels to 9,200 hours and the associated fee schedule
- She stated the rates outlined in the fee schedule captures the Authority's cost in providing service
- Ms. Matheny confirmed a zero net financial impact to the Authority for implementation of the revised operational schedule as presented
