- Mr. Coudriet stated the purpose of the specially called meeting as to identify a new Executive Director for Wave Transit before entertaining a motion and discussion
- Mr. Kozlosky made a motion that the board enter into a contract with Marie Parker as the new director for the Cape Fear Public Transportation Authority

- Ms. Parker thanked everyone for their confidence in her and stated she is genuinely looking forward to joining the team
- The board congratulated Ms. Parker on her appointment and stated they are looking forward to working with her
- Mr. Lawler inquired about her start date
- Mr. Coudriet confirmed the start date as December 7, 2020
- He confirmed this date as the date in which Ms. Deb Hayes will be seated on the County Commission
- Hearing no further comments, Mr. Coudriet moved to the next item on the agenda
