## **DESCRIPTION OF DUTIES/RESPONSIBILITIES:**

The following duties are normal for this position. These are not to be construed as exclusive or all inclusive. Other duties may be required and assigned.

- Assist in the removal or installation of all units on any company vehicle with supervision
- Service vehicles without supervision
- Ensure vehicles operate in a safe, comfortable, like-new condition by performing highest quality maintenance repairs on all aspects of vehicle systems
- Perform quality preventive maintenance inspections on all vehicles and equipment assigned to the property
- Assist in diagnoses and repairs to mechanical, electrical, HVAC, pneumatic, hydraulic systems, transmissions, and gas/diesel engines, with supervision and help as needed
- Assist on road calls, on-the-road repairs, and road tests as needed
- Properly complete work orders and signing out of parts when used on vehicles
- Keep all company tools and equipment clean and in good working order
- Work well with all other departments, co-workers, and supervisors
- Demonstrate the ability to work in a safe manner
- Perform shop cleanup at the end of shift
- Ability to learn and comprehend maintenance manuals, parts books, and electrical diagrams
- Must have own tools up to once inch and toolbox

## **QUALIFICATIONS:**

- High School Diploma or G.E.D.
- Minimum one-year automotive or heavy-duty truck repair experience
- General knowledge of cranking, charging, electrical, and hydraulic systems.
- Ability to use both standard and metric tools required.
- A drug test and pre-employment physical exam is required
- · Must maintain driver insurability standards
- Be able to obtain a valid Class B North Carolina Commercial Driver's License with Air Brakes and Passenger endorsements to be able to operate and switch off buses.
- Maintain current DOT physical certification, and a good motor vehicle record.
- Must be able to lift up to fifty pounds.
- Must be able to climb and work from ladders and other lifts.
